



2010 Nonprofit Scholarship Application for the Mastering Leadership Dynamics Program

Requirements of applicant:

1. At the time of application: Participant must be an executive leader or a direct report of an executive leader and gain approval from the Board Chair to apply for the Mastering Leadership Dynamics program. The Board Chair will then complete the "Recommendation Page" indicating their approval and send to:

2. Upon acceptance:
 - a. Designate a Board Member to act as a coach through the pre-work and the Leadership Launch Point, which is a brief follow-up session after the workshop.
 - b. Complete registration form and payment (\$350 for cost of materials due at registration).
3. Subsequent to the workshop: Participant conducts a brief presentation to the Board of Directors immediately following graduation from the Mastering Leadership Dynamics program (to include: participant expectations, participant outcomes, and recommendations for future partnerships with Farr).

Nonprofit Organization Requirements:

- Fulltime professional Executive
- Professional outside Board of Directors
- At least 5 full time employees
- Documentation that the organization is a 501(c)(3)
- Limit of one scholarship per organization

* Cancellation Policy Effective Upon Completion of Registration: If a participant cancels/reschedules at least 31 days in advance no penalty will incur. If a participant cancels 30 days or less prior to the workshop they may either find a replacement from the same or similar organization and of comparable Executive Level OR will be charged 100% of the scholarship rate at the time of cancellation. Rescheduling less than 30 days in advance will not be accommodated.
